As of 01.01.2017 the lawmaker requires from your register system:

- Data collection log: a complete, continuous and chronological memory of receipts of the register. Consisting of method signature journal, event log, business transaction (=register journal) and core data log.
- Receipt printer or device for the electronic transmission of receipt for payment
- Interface for a safety device with a signature creation device (It must not be possible to collect payment without a safety device, i.e. no bypassing the safety device)
- Encryption algorithm AES 256 (for encrypting data)
- A unique register identification number

The PLAN PRO EFSTA system is an add-on to your existing LS One register that can meet all statutory requirements with ease.

According to the desired range of functions, the default settings of the RKSV (the provision on register security, which stipulates keeping encrypted journal data) will manage automatic reports to the tax office, keep account of business transactions and safely store the receipts for the stipulated period of seven years.

When you decide to use the full potential of the EFSTA solution, you can safely make your receipts available to your auditor via download, manage your register online or receive notifications when questions arise. In doing so you run no risk of data falling into the wrong hands since everything is encrypted to the highest degree and only you hold the required key.

The EFSTA-supported register additionally offers the following:

The LS One register system supports various countries, which means that you can adjust to suit the fiscal mode of another country and legally do business there as soon as the module is implemented.
